

# Black Prong Equestrian Village Standard Terms and Conditions

Effective November 1, 2024

The following Standard Terms and Conditions apply to each reservation for Accommodation and Guest Pass purchase at Black Prong Equestrian Village ("the Property") and govern the relationship between the individual booking the reservation or purchasing the Guest Pass ("Guest") and Black Prong Equestrian Village LLC ("Black Prong"). Upon booking a reservation or purchasing a Guest Pass, whether online, by phone or in person, the Guest is deemed to have read, understood and accepted these Standard Terms and Conditions. Additionally, the Guest will be required to confirm agreement with the terms and conditions herein and to individually sign and have all members of the Guest's party to sign, the Black Prong General Release, Liability Waiver and Assumption of all Risk and Liability either electronically at https://blackprong.com/ or upon arriving at Black Prong.

Access to Black Prong Facilities: Guests are only permitted in the designated guest areas of Black Prong. An active Accommodation reservation or Guest Pass are required for travel beyond the visitor areas. All visitors must register at the office upon arrival and be met there by Guest.

**Occupancy:** Guest must be at least 18 years old, occupy the Accommodations for the entire length of the stay and comply with the occupancy terms herein. Minors under the age of 16 must be accompanied by an adult at all times.

Reservations, Payments and Fees: A two-night minimum reservation is required on all accommodation bookings which include a Friday or Saturday or a major holiday. A 30% deposit is required at booking to confirm your reservation. Reservations made without the required deposit will be cancelled automatically at the end of the 2<sup>nd</sup> business day. Reservations for less than 30 days are payable in full upon arrival. For reservations of 30 days or more, the remaining balance is payable over the length of the reservation on a prorated basis with payments spread between arrival and 30-day arrival anniversaries. For reservations of 120 days or more, a 10% discount is applied to the booked rate after the 30% deposit is paid upon receipt of payment for the remaining balance due, which must be received no later than 30 days prior to scheduled arrival. If a Guest does not adhere to their agreed-upon payment schedule, they will be checked out early and subject to the Cancellation Policy. All apartments, cottages, tiny homes, campers, RV sites, and camping sites ("Accommodations") are subject to an 11% lodging tax. Stalls are subject to 7% sales tax. Additional fees may apply based on Guest's purchases and activities on the Property, to include room service, convenience store purchases, food truck purchases, activities and use of certain amenities, and other charges as outlined herein, to include but not be limited to those fees defined in the Fee Schedule attached as Exhibit A and incorporated herein. Long term RV Site rentals will be subject to Utility Overage Fees, and may be subject to Administrative Fees, for electric service usage over the 750kwh per month allowance. Guest authorizes payment to Guest's credit card for reservation of and payment for Accommodations, store/amenity/activity/food/room service fees, guest fees, damages to Black Prong facilities, equipment or property, lost or stolen equipment rental or Accommodation keys, RFID Cards, or other rental accessories, and other charges incurred or caused by Guest, or members of Guest's party, without further notice. Guest agrees to pay for any and all fees upon invoice if credit card charges are disputed or declined.

Check-In and Check-Out Procedures: Guest must check in at the main office upon arrival. Check-in time is 3:00pm – 5:00pm for cottage, tiny home, and airstream Accommodations and 1:00pm – 5:00pm for RV Pad Accommodations. Late arrivals must be prearranged and may result in a Late Arrival Fee. Guest must present a valid government issued photo ID and matching credit card upon check-in. If the credit card presented at check-in does not match the one used for the advanced deposit, then the full stay will be authorized on the new card. The credit card must be valid for, and will be retained on, the Guest's account for the duration of their reservation. Check-out time is 11:00am for all reservations. Late check-out may result in a Late Departure Fee. Upon check-out, Guest shall leave the Accommodations in substantially the same condition as they were at check-in, with all garbage removed and placed into the appropriate trash receptacles.



**Maximum Occupancy:** Only one horse is permitted per stall. Only one camping unit is permitted per RV site. The maximum occupancy limit for cottages, tiny homes and airstreams is determined by the specific accommodation reserved and is provided to Guest during both the reservation booking and confirmation processes. Guest is responsible for ensuring that Guest, and all members of Guest's party, adhere to the maximum occupancy limit for the Accommodation reserved. A breach of the maximum occupancy limit, without prior written approval from Black Prong, will result in an Additional Guest Fee for each additional member of Guest's party and/or overnight visitor which exceed the occupancy limit.

**Keys and Locks:** Black Prong will provide keycards, RFID Cards, and/or bracelets to Guest which Guest is to return at the conclusion of Guest's stay. Failure to return these items at departure may result in Guest being charged a Replacement Fee.

Stalls and Tack Rooms: All horses on the Property overnight will be subject to stall fees. Guest agrees to leave stalls and tack rooms swept clean and free of manure, trash and other debris upon departure. If Guest fails to leave stalls and tack rooms in clean order, Guest will be charged a Stall Cleaning Fee and/or a Tack Room Cleaning Fee. Guest will provide bedding and stall cleaning, depositing all manure and bedding in the designated waste container located near the stalls. Black Prong will provide the waste container, and regular dumping services, at no additional charge to Guest. Fine, flake, and pelleted shavings are available for sale and can be ordered in the main office. Straw, cardboard, paper shavings or other bedding materials are not permitted.

**Accommodation Substitutions:** Black Prong reserves the right to substitute any Accommodations reserved for similar alternate Accommodations, if necessary, at the sole discretion of Black Prong.

**Vehicles:** All motorized vehicles, including golf carts, UTVs, ATVs, and horse trailers used at Black Prong must be properly registered with Black Prong and with the appropriate governing body, insured and operated by a licensed driver. Proof of licensure, registration and insurance shall be provided upon request. Motorized vehicles are only permitted to be driven on the roadway and are expected to observe the 10-mph speed limit on the Property. Horses have the right-of-way at all times and in all locations on the Property. Cars, trucks, and horse trailers are not permitted to be driven on or across the Property other than for the purpose of delivering people, animals, or supplies and for traveling to designated long term parking areas. Black Prong will provide one high quality electric golf cart with each Accommodation for use on the Property. Guests may choose not to use the Black Prong electric golf cart and may bring personally owned electric golf carts or utility vehicles for use on the Property. The golf cart will be considered a rental and the damage clause in the Rental terms will apply.

Parking: All cars, trucks and horse trailers are required to remain parked in designated long term parking areas while on the Property. Traveling on or across the Property in or with cars, trucks or horse trailers, and parking is restricted to guests with Accommodations and only be permitted for delivering people, animals, and supplies. Cars and trucks are limited to 30 minutes of parking (2 hours for guests staying 30 days or more) outside of the designated long term parking areas. Horse trailers are permitted 24 hours of parking on the Property, before being parked in long term parking at the Black Prong RV & Self Storage location. Parking outside of the designated long term parking areas for longer than permitted will result in Unauthorized Parking Fees for the first and second offense, and immediate cancellation of Guest's reservation and removal from the Property, without refund, for the third offense. Guests parked on the Property are doing so at their own risk. Guests are strongly encouraged to secure vehicles and personal belongings while on the Property. Black Prong is not responsible for any loss or damage to any vehicle or items left in Guest's vehicle while parked in any location on or off the Property.

**Rentals:** Black Prong maintains an inventory of items and equipment, including golf carts, bikes and kayaks, which are available for guest rental. Additional golf carts can be rented by properly licensed individuals and are permitted to be used for transportation on and across the Property. Bikes are provided at no additional charge on a first-come, first-served basis and are permitted to be used on or across the Property and into the Goethe State Forest for trail riding. Bike helmets are required. Guests will return bikes to the designated area at the end of each ride or day. Bikes are not to be stored at Guest's Accommodations. Kayaks, paddles and life jackets are available for rent for off-



site use as a courtesy, with Black Prong assuming no responsibility or liability for their use. No warranty is provided regarding the suitability of the kayaks for any particular activity or location. Guests use the kayaks at their own risk, and Black Prong holds no responsibility or liability for any usage, including if Black Prong staff offer location recommendations for their use. Guest must return all rentals in the same condition as received, only ordinary wear and tear excepted. Guest is fully responsible for all damage, loss, or theft of the rentals, and of any damage to accommodations, property, or facilities at Black Prong, to include loss, damage, or theft of keys, RFID cards, and other accessories to rentals, accommodations, property, or facilities, caused directly or indirectly by the action or inaction of Guest or a member of Guest's party, whether or not resulting from a deliberate, negligent, or reckless act or omission, while rented in Guest's name, and Guest shall indemnify Black Prong for the same.

Horses: All horses on the property are required to have a negative annual Coggins test and proof of flu rhino vaccines dated within 6 months of scheduled arrival on file in the main office. Documentation must consist of the following: In the case of vaccines administered by a veterinarian (highly recommended), Guest must provide documentation from the veterinarian documenting that the horse in question received the vaccinations, name of the vaccines and date of vaccine administration. A letter from the veterinarian on official letterhead with the name of the horse (or horses), name of the vaccines and date of vaccine administration and signed by the veterinarian is acceptable documentation. In the case of vaccines administered by a person other than a veterinarian, Guest must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, Guest must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the Property. These horses must also have their temperature taken and logged twice daily while on the Property. The log of temperatures shall be provided to the Black Prong office.

Equestrian guests must bring their own feed buckets, hose, rakes, muck buckets, etc. Paddocks are assigned on a first come first served basis. Name tags are affixed to all occupied paddocks. Guest is solely responsible for the care, custody, and control of all Guests horses at all times without exception, whether in the stalls or any other locations on the Property. Guest understands that Black Prong has no obligation, responsibility or liability with regard to Guest's horses. Guest agrees to indemnify and hold Black Prong harmless from any claim related to Guest's horses, to include any and all property damage and/or injury caused by the actions of the Guest's horses, and any and all attorney's fees and costs incurred with respect to any claim asserted whether or not a lawsuit is filed.

Pets: Pets are welcome on the Property if under the constant supervision of Guest and do not create a nuisance or disturb other guests. Pets are not permitted to be left unattended in the Black Prong provided Accommodations and must be properly leashed at all times unless they are contained indoors inside the rented Accommodations or within the dog park. Guest is responsible for cleaning up after Guest's pets. Sanitary bags are provided in each Accommodation and are available in the main office. Waste Stations are provided at various locations throughout the Property. Guest is responsible for any and all property damage and/or injury caused by the actions of Guest's pets, and any pest infestations spread to the Property and/or Accommodations by Guest's pet. If Guest brings a pet onto the Property and stays in Black Prong provided Accommodations, Guest will be charged a Pet Cleaning Fee. Damages to Accommodations caused by Guest's pet are not included in the Pet Cleaning Fee and will be billed to Guest directly based on cost of repair or replacement. If Black Prong determines, in its sole discretion, that deep cleaning is required in order to properly prepare the Accommodations for the next guest due to the conditions left behind by Guest's pets, Guest may be charged a Maintenance Deep Cleaning Fee in addition to the Pet Cleaning Fee.

**Florida Wildlife:** Black Prong is surrounded by the Goethe State Forest on three sides of the Property. Due to the proximity of the Forest, Guest may have an increased risk of encountering Florida wildlife while on the Property. Guest and their pets are urged to approach all outdoor areas with caution. Black Prong shall not be responsible for any injury or death of a Guest or a Guest's pet while on the Property.



Conduct and Use of the Property: While on the Property, Guest is required to follow all state and federal laws, and all rules and policies of Black Prong posted on the Property, and all Property rules, policies, and instructions verbally communicated to Guest, at all times. Smoking and vaping are prohibited in Black Prong provided Accommodations and in all buildings and structures on the Property. If Guest smokes or vapes in other areas on the Property, Guest must properly dispose of any remnants in the appropriate trash receptacles. Campfires are only permitted in and with the use of an approved fire ring, which can be obtained from the Black Prong office. Fireworks are not permitted on the Property. Guest shall not litter or leave garbage thrown about and shall dispose of all garbage in the appropriate trash receptacles. Guest is required to take appropriate safety precautions while engaged in activities at Black Prong, to include wearing a helmet during equine and cycling activities. Guest is responsible for ensuring all members, including children, in Guests party follow all rules and policies, take appropriate safety precautions and use appropriate safety equipment while engaging in activities at Black Prong. Guest is prohibited from touching or feeding other guests' horses or pets, without express permission from the horse or pet owner. While in the rented Accommodations and while utilizing common areas, Guest agrees not to cause any nuisance or disruptions on the property, and to be mindful and respect the right of enjoyment of others on the Property. Guest agrees to observe and respect quiet hours from 10:00pm to 7:00am. Violations of this section may result in immediate cancellation of Guest's reservation, and removal from the Property, without refund.

**Emergencies:** For the safety of Black Prong guests and staff, an emergency phone is located on each side of the Property which can be dialed directly to Black Prong staff or to 911 emergency services. If there is an emergency on the Property and Guest cannot safely get to one of the emergency phones, Guest should dial 911 directly from Guest's phone and provide them with Guest's location on the Property for immediate attention. In the event of an after hours situation that does not require immediate emergency services attention, Guest can call the Black Prong staff at 352-486-1234 and press Option #1. Guest understands that Black Prong staff does not provide emergency medical care.

Goethe State Forest Access: Black Prong has three exits to the Goethe State Forest from the Property for Guest to use in exploring the Forest on foot, by bike, horseback, or carriage. Motorized vehicles are not permitted in the Forest. If Guest takes a motorized vehicle into the Forest, Guest may be subject to fines by Forestry officials. In order to enter the Forest Guest must have a valid pass from Florida State Parks. Guest agrees to adhere to all rules and regulations of the Goethe State Forest when using access points from Black Prong. Guest understands and agrees that Black Prong has no responsibility or liability with regard to the use of Goethe State Forest property, including but not limited to activities Guest may engage in with maps, guidance or materials provided to Guest by Black Prong. Guest agrees to indemnify and hold Black Prong harmless for any and all claims arising out of Guest's use of and activities engaged within the Goethe State Forest, including but not limited to attorney's fees and costs relating to any claim whether or not a lawsuit is filed.

Swimming Pool and Hot Tub: Guest will adhere to the rules and policies posted in the swimming pool and hot tub area, and all rules, policies, and instructions verbally communicated to Guest, at all times while using these facilities. Guest understands and acknowledges that no lifeguard is on duty and Guest assumes the risk and responsibility relating to use of the swimming pool and hot tub. Direct adult supervision is required for all children under the age of 16. Black Prong endeavors to heat the pool and hot tub as much as possible throughout the year. However, Black Prong cannot guarantee that the pool or hot tub will be heated to every Guest's satisfaction. No refunds will be provided due to Guest being unsatisfied with the temperature of the pool or hot tub.

Access to Accommodations: Black Prong may enter the rented Accommodations as reasonably necessary for protection of guests or employees; for inspection; for repairs or other services; or for any emergency. Notice shall be provided, as Black Prong, in its sole discretion, deems appropriate. No notice shall be required if Black Prong deems, in its sole discretion, there to be an emergency.

Maintenance and Repairs: Accommodations are inspected prior to Guest arrival to ensure that there is no need for maintenance or repairs. Guest must report any deficiencies in the Accommodations within 24 hours of arrival. Reports and/or maintenance requests should be made by calling the main office at (352) 486-1234 or by submitting



an electronic reporting form via email to notifications+bpev@onupkeep.com. The electronic reporting form can be accessed by using the provided QR code. Responses shall be made in a timeframe and to the degree deemed appropriate in the sole discretion of Black Prong. Absent negligence on the part of Black Prong, faulty equipment, appliances, or services; bugs inside the Accommodations; construction noise; a warm refrigerator; or inclement weather, and other similar complaints do not constitute breach of contract, nor shall it provide a basis for a refund or abatement of Fees.

Amenities and Additional Services: Black Prong may provide access to certain amenities or provide additional services for guests, from time to time, in its sole discretion. The fact that Black Prong provides access to an amenity or additional service does not obligate Black Prong to provide the same to another guest or group of guests, nor does it obligate Black Prong to provide additional access or additional services to the same guest at a later time. Other than what is outlined herein, Black Prong does not guarantee the use of any specific amenities or receipt of additional services.

Day, Season & Monthly Passes: Local guests have the option to purchase a Day, Season or Monthly Pass to access and enjoy certain amenities and services at Black Prong ("Guest Pass"), subject to the applicable terms and conditions outlined herein. Guest Passes are not transferable and are only to be used by the individual guest or family issued the pass in accordance with the terms of the Guest Pass, which are provided at purchase and available at www.blackprong.com/community-pass/. Guests are not permitted to share passes with friends and family or allow any individual to use their pass to access Black Prong amenities or services. Violation of this section or failure to follow Black Prong rules and policies will result in a formal notice for the first offense and suspension or revocation of the Guest Pass for the second offense, at Black Prong's sole discretion, without refund.

Cancellations and Refunds: Short Term Stays/Reservations (1-29 days): Deposit is 100% refundable if the reservation is cancelled at least 14 days prior to the scheduled arrival date, 50% refundable if cancelled between 13 and 4 days prior to the scheduled arrival date, and nonrefundable if cancelled less than 4 days prior to the scheduled arrival date. Long Term Stays/Reservations (30 or more days): Deposit is 100% refundable if the reservation is canceled at least 60 days prior to the scheduled arrival date, 50% refundable if canceled between 59 and 30 days prior to the scheduled arrival date, and nonrefundable if canceled less than 30 days prior to the scheduled arrival date. If a guest departs before the end of their reservation, no additional cancellation penalty will apply, but the guest will forfeit their remaining excess payment.

**Email and Text Communications:** Black Prong will communicate with Guest in various ways, including by email and text message. Guest agrees that by providing Black Prong with Guest's email address and mobile phone number, Guest is expressly providing consent to receive both informational and promotional communications from Black Prong, and affiliated entities, by email and text message, and hereby waives any claims against Black Prong, or affiliated entities, regarding such communications.

Damage to Black Prong Property: Guest is responsible for any and all loss, theft, or damage to the Accommodations, premises, Property, rentals, facilities and equipment thereon, caused directly or indirectly by the actions or inaction of Guest or any member of Guest's party, incurred during Guest's stay at the Property, whether or not resulting from a deliberate, negligent, or reckless act or omission. Damage to rooms, fixtures, furnishings, facilities, and equipment, including but not limited to the removal of electronic equipment, towels, and artwork, will be reimbursed by Guest at 120% of full and new replacement value plus any applicable shipping and handling fees. Damage to mattresses and linens, including towels, mattress pads, sheets, bedspreads, and blankets, resulting from the use of body oils, make-up, shoe-polish, or similar substance will be reimbursed by Guest at 120% for the special cleaning, repair or replacement of the damaged item. Accommodations found at checkout to have trash and other debris, which is not properly contained, in a disordered state not consistent with normal and customary conditions, and/or unnecessarily made untidy or unclean, to include conditions due to Guest's pets or unauthorized smoking or vaping which requires deep cleaning in order to properly prepare the Accommodations for the next guest, will be subject to a Maintenance Deep Cleaning Fee, Administration Fee and/or Third-Party Fees. Black Prong reserves the right to retain Guest's credit card or debit card details as presented at registration and Guest hereby explicitly authorizes Black Prong to



charge or debit the credit or debit card such amounts as it shall, in its sole discretion, deem necessary to cover the cost or expenses incurred or suffered by Black Prong due to the actions or inaction of Guest, or any member of Guest's party. Black Prong will make reasonable efforts to rectify any damage internally prior to engaging a specialist to make repairs in order to mitigate the costs for which Guest is responsible.

**Liability for Property of Guest:** All of Guest's property of every kind or description which may at any time be in the Accommodations, and on the premises or Property, shall be maintained at Guest's own risk. Guest is responsible for keeping up with, caring for and insuring Guest's property. Black Prong is not responsible for any damage to or loss of Guest's property, or the property of any member of Guest's party.

Lost and Found Items: Black Prong is not responsible for any personal items left behind on the Property. Guest will be responsible for all mailing and shipping charges, as well as a Processing Fee for any lost and found items requested to be returned to Guest. Location of lost items may be delayed due to ability to gain access to Accommodations to look for said items. Black Prong shall not be responsible for nor held liable for any items left behind in the Accommodation which are not located. All lost and found items are held for a period of 14 days after departure, after which time the items will be disposed of in a manner deemed reasonable in Black Prong's sole discretion.

Assumption of Risk; Limitation of Liability: Guest acknowledges, understands and accepts that there are certain risks associated with Guest's stay at the Property and with Guest's participation in events and activities on the Property, and when accessing the Goethe State Forest, to include possible injury, death, and/or exposure to illness from infectious diseases, and Guest hereby voluntarily assumes those risks and holds Black Prong harmless for any injury or damage.

Under Florida law, an equine activity sponsor, equine professional, or any other person or legal entity is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities. As an agritourism operator, Black Prong is not liable for injury or death of, or damage or loss to, a participant in an agritourism activity conducted at this agritourism location if such injury, death, damage, or loss results from the inherent risks of an agritourism activity. Inherent risks of agritourism activities include, among others, risks of injury inherent to land, equipment, and animals, as well as the potential for Guest to act in a negligent manner that may contribute to Guest's injury, death, damage, or loss. Guest assumes the risk of participating in agritourism activities on the Property.

In no event shall Black Prong be responsible for special, indirect, incidental, consequential, punitive, or exemplary damages arising from or in connection with Guest's reservation or stay or activities on the Property. Black Prong's total aggregate liability arising under this booking shall not exceed the amount received from Guest for Guest's Accommodations.

Indemnification: Guest agrees to indemnify, defend and hold harmless Black Prong, its affiliates and their respective members, managers, officers, employees, representatives and agents, from any loss, damage, claim, cost or expense, including but not limited to reasonable attorneys' fees and expenses of litigation, resulting from Guest's use or occupancy of the Accommodations, Guest Pass, participation in events and activities on the Property, when accessing the Goethe State Forest, Guest's negligence, violation of applicable law, breach of Black Prong's policies, rules and regulations (posted, written or verbal) or of the terms and conditions stated herein, and/or any claim made or action brought by an employee, a customer, or a guest of Black Prong as a result of an accident or occurrence on the Property. Guest has executed Black Prong's General Release, Liability Waiver and Assumption of All Risk and Liability form (the "Agreement") and understands the Agreement is incorporated into these Standard Terms and Conditions and applies to the Guest and their use of the Accommodations and the Property.

Photo and Publicity Release: Guest hereby grants to Black Prong the irrevocable, perpetual right and permission to use Guest's name, portrait, photograph, image, appearance, voice, and likeness for Black Prong's business, commercial, advertising and/or trade purposes, to include, without limitation, inclusion on Black Prong's website and social media platforms. Guest hereby waives any right of attribution and any right to payment or an accounting from Black Prong relating to this use and waives any right Guest may have for inspection or approval. Guest hereby



releases Black Prong, and its members, managers, officers, employees, representatives and agents, from any claims Guest may have against Black Prong relating to Black Prong's use of Guest's name, portrait, photograph, image, voice, or likeness, whether arising before or after Guest's current reservation.

**Force Majeure:** Black Prong shall not be held responsible for and will not issue a refund for any reservations that are canceled, prevented, restricted or interfered with by circumstances beyond its reasonable control, including without limitation, earthquake, fire, flood, Act of God, hurricane, red tide, storms, wars, civil or military disturbances, environmental hazards, epidemic, pandemic, extended power outages, mandatory evacuation orders, or any other cause whatsoever beyond the reasonable control of Black Prong. In the event Guest attempts to cancel Guest's reservation, arrive late, depart early, or otherwise alter Guest's reservation as a result of any of the foregoing, Guest will be subject to the Black Prong Cancellation Policy as detailed herein.

Subleasing: Guest is prohibited from subleasing Accommodations and/or stalls or paddocks.

**Violations:** Violations of the terms and conditions outlined herein may result in immediate cancellation of Guest's reservation, and removal from the Property, without refund. Black Prong shall further pursue remedies for violations of these Standard Terms and Conditions, in its sole discretion, by any means provided for herein and by law. Failure of Black Prong to enforce any obligations contained herein shall not be construed as a waiver of or release from the obligation nor shall it bar Black Prong from pursuing remedies for violations of the same or similar obligations in the future.

**Modifications:** Black Prong may modify these Standard Terms and Conditions at any time in its sole discretion.
